

To establish, manage and / or take over institutions of cultural, humanistic, sociological, technical, legal, agricultural, industrial (including small scale, home land village industries) commercial, a lahic maden keeny talin medical and philanthropic characters like Nursery / Primary / High schools, Colleges, Post-Graduates courses of study and researches or such other institutions.
 - c. To establish, manage and conduct or to take over computer / IT institutions.
 - d. To establish, manage and / or take over training institutes such as Industrial Training Institutes, TCH, NTC, B.Ed., Vocational Training, Physical education training institutions etc.,

- h. To impart moral education and to initiate schemes to create in younger generation a sense of study and discipline and to train them in art of leadership, to inspire in them sense of mission and teach them the basic values of life.
- i. To impart instructions in Arts and Crafts such as Tailoring knitting, waving, Drawing, Design and Dress making, fine arts drawing etc.

 - Solicit, obtain or accept subscriptions, donations, grants, gifts, devices, bequests and trusts from any persons, firm, corporation or institution or any Govt. or local or public body or authority.
 - Take such steps by personal or written appeals exhibitions, public meetings, entertainment's or otherwise, howsoever as may from time to time be deemed expedient for the trust in the shape of donations, legacies, annual payments or otherwise.
 - Sell, manage, transfer, exchange, mortgage, charge, lease, dispose of or otherwise deal with any property whatsoever belonging to trust.
 - Employ competent and / or expert staff, workers, attendants and employees in carrying out of the aforesaid objects upon such terms as to remuneration's or otherwise as may be thought fit.
 - Do all such other acts, matters, deeds and things as may be necessary, incidental or conducive to the attainment of all or any of the objects above mentioned.

- c. The clauses of this bye-laws related with cessation of trusteeship or disqualification or removal shall not be applied to founder life time trustees.
- d. This trust can co-opt any citizen of India who will be beneficial for the achievements of the objectives of this trust with convinces. All the trustees should approve his name. This can not be done if any trustee votes the decision.
- e. The Board of Trustees shall consist of 21 trustees. AI LIFE TIME FOUNDER TRUSTEES shall constitute and form the Board of Trustees.
- f. In case of any vacancy amongst the Trustees occurred by reason of death or resignation, the nominee of the deceased may be appointed as trustee by 2/3rd majority vote.
- g. In case of resignation or insolvency or removal of any trustee or for any other cause, the remaining trustees shall have power to appoint a new Life Time Trustee.
- h. Till the vacancy or vacancies are duly filled up the remaining trustees shall constitute the Board of Trustees.
- i. A Trustee shall be automatically disqualified from holding the trusteeship of the Trust, if he is declared insolvent or becomes lunatic or convicted by the competent court, for an offence involving moral turpitude or fails to attend continuously six meetings without prior intimation in writing of the Board of Trustees and shall ceased to be Trustee of this Trust.
- j. Any Trustee may retire from the Board of Trustees and relinquish his office hereof by giving 3 months advance notice in writing of his retirement or resignation.
- k. The office of the Trustees shall be honorary, they are entitled to draw sitting allowance and such other allowances and honorarium as are prescribed by the Board for carrying out their duties.
- l. Any Trustee if incur expenditure out of his personal funds in discharging his duties as a Trustee under authorization of the Board of Trustees, he shall be entitled to recover the same from the Trust by producing proper accounts therefore.

- m. Any Trustee can be removed from the Trust for gross misconduct or misappropriation of funds of the Trust by 2/3rd majority votes.

6. OFFICE BEARERS OF THE TRUST

- a. The Board of Trustees shall consists of One Chairman, One Vice-Chairman, one General Secretary, one Joint Secretary, One Treasurer and an Internal Auditor once in 3 years among themselves by a vote of simple majority. The term of these office bearers shall be 3 years. Any of the office bearers may be removed from the post he held by 2/3rd majority vote of the Board of Trustees.
- b. Chairman : The Chairman shall preside over all the meetings of the Trust and all the functions, public or otherwise of the Trust. If Secretary fails to convene 3 successive meetings, the Chairman shall convene the meetings.
- c. Vice-Chairman : In absence of one of two Chairman, the Vice-Chairman by rotating shall carry out of the duties of Chairman.
- d. SECRETARY :

1. The Secretary shall be incharge of all the records of all the records, documents, correspondence and other records pertaining to the administration of the Trust.
2. He shall correspond with the general public, officials, departments, institutions, organizations etc., in day to day activities of the Trust which is necessary or deemed necessary.
3. The Secretary shall be responsible for convening and conducting the meetings as and when so required and maintain the records thereof.
4. The Secretary shall look after the general administration and management of the Trust in accordance with the terms and conditions of this deed to fulfill the aims and objects of the Trust.

5. All the suits and cases on behalf of the Trust shall be filed, prosecuted, conducted and defended by the Trust represented by its Secretary.
6. All the deeds and documents of the Trust shall be prepared in the name of the Trust represented and signed by the Secretary and Chairman.
7. In fine, the Secretary shall be the Chief Administrative and Executive Officer of the Trust and any acts, deeds of things done by the Secretary in carrying out the aims and objects of the Trust shall be binding on the Trust.
8. During the absence of the Secretary for long period (not less than one month with prior intimation).
9. Treasurer : The Treasurer shall receive and maintain all the monies, subscriptions, donations, finance etc., of the trust and account for the same by maintaining proper account books, like day to day cash book, ledgers of Income and expenditure etc. He should make available all the account books for inspection by the Trustees at reasonable hours.
7. The account of the Trust shall be opened in any Nationalized or Scheduled Bank in Gulbarga city in the name of the Trust. The Bank account shall be operated jointly by Treasurer along with the Chairman / Secretary or one of the founder trustee become fit.
8. The management and control of the properties land affairs of the Trust shall be vested in the Board of founder trustees, represented by the Secretary.
9. Internal Auditor: All the accounts of Trust shall be audited and checked by the Internal Auditor at regular intervals and submit his report therefore as and when required.

15. The founder trustees shall have the power to amend, alter or rescind any of the provisions of the Trust in a manner not inconsistent with the objects of trust and to interpret their meanings whenever the rules and regulations framed do not cover any emergency or is ambiguous, provided that such change or interpretations do not conflict with aims and objects of the Trust.
16. The income and property of the Trust, when so ever derived, shall be applied solely towards the promotion of the objects of the Trust as sent forth in this deed and no portion thereof shall be paid or transferred directly or indirectly by way of dividends bonus or otherwise, howsoever by way of profit to the trustees of the Trust or to any person claiming through any of them. Provided that nothing herein contained shall prevent the payment in good faith of reasonable or proper remuneration to any officers, servants, attendants of employees of the Trust or to any Trustees or other person in return of his service, actually rendered to the Trust, but so that no Trustee shall be appointed to any salaried office of the Trust.
17. For any matter for which no specific provision are made in this deed, the provisions of Indian Trusts Act 1982 shall apply to that extent.

18. **INVESTMENT CLAUSE :**

The fund of the Trust may be invested in the modes specified under the provisions of S 13 (1) read with S 11 (5) of the Income Tax Act 1961.

19. **ACCOUNTS CLAUSE :**

There shall be maintained all accounts of the Trust regularly. The accounts shall be audited by an Auditor every year.

20. **AMENDMENTS CLAUSE :**

No amendments to the Trust Deed and rules and regulations shall be made which may prove to be repugnant to the provisions of SS2(15), 11 to 13 and 80 (G) of the Income Tax Act 1961. However no amendments shall be carried out without the prior approval of the Commissioner of Income Tax.
